As I embark on my 27th year as PGA Golf Professional at Pine Acres CC and my first year as your President, I wish you a happy and healthy 2012 golf season.

Your officers joined myself, Executive Director Joe Bertino and Tournament Director Steve Bartkowski at the 95th PGA Annual Meeting in Orlando, Florida in January. The focus again was Golf 2.0 and three resolutions to our PGA constitution. Although it was difficult to focus with all that sun, we managed to get through it. I don't know about our other section leaders but I felt like a bat coming out of a cave.

The National PGA is challenging all of us to adopt this initiative. They provided us with a gameplan for the success of Golf 2.0. Please visit the Golf 2.0 website to download all the materials needed to execute this plan to drive new golfers to the game, as well as, keep our core golfers and interest the lapsed golfer. Please share any successes you have in attracting new golfers. We, at Pine Acres have married ourselves to a local university to help with this process. They have the marketing expertise and the sports management expertise, along with a business development team that is helping with research on vital regional statistics.

Two of the three resolutions passed were related to permitting Apprentices and A-8's to transfer Sections more than once during a fiscal year and to allow "century" life members with 25 years of service and 75 years old to a reduced dues schedule.

The resolution that was defeated was to allow all university golf coaches credits toward membership without the supervision of a PGA Member.

In March, your Section Leaders will be attending a District Meeting in Hartford, Connecticut to interview prospective candidates for National PGA Secretary.

It's not too early to be thinking about the 2013 PGA Championship at Oak Hill Country Club. We will be counting on our Section members to donate their valuable time to fulfill our responsibilities for the championship.

Note from Joe Bertino, Western New York PGA Executive Director

...So much for that snowplowing contract- what a winter! As Kirk Stauffer mentions, two of the three resolutions presented at the PGA Annual Meeting passed. In fact, Resolution #2 (Transfers) was amended on the floor to include all membership classifications, not just A-8's, enabling any PGA Member to transfer sections more than once per fiscal year, so long as they are employed and working in an active classification (full time, eligible employment) in the new section.

With intense focus on Golf 2.0, an important consideration for all is the new MSR requirement schedule which will begin this June 16th, with a cycle end of June 15, 2015. Effective this 6/15, PGA Members will be required to achieve a total of 54 MSR credits, with a MINIMUM of 36 credits coming from PGA Section (chapter) or National Meetings & Education, and Golf 2.0. Notably, meeting attendance after the cycle start date will receive 1 credit per hour of attendance, not the two credits received currently. Credit for Golf 2.0 will be awarded for promoting, conducting, AND reporting results of Golf 2.0 Programs that engage or create golfers. Credits will also be earned for completing PGA online Golf 2.0 tutorials and training. Please note that any credits that you've acquired this past year will remain as earned and count toward the new 54 credit total that begins this summer.

The WNYPGA Spring Meeting is coming this April 16th to Transit Valley CC, East Amherst, NY. We ask that you register online or call the office for registration (no charge) so that we can give an accurate count to the club for continental breakfast and lunch. Education will take place following lunch that Monday, stay tuned for further details.

Registration for our junior golf tour is in full swing now, so please take a moment to remind your juniors to sign up while space still exists! Many thanks to those who generously give us access to their clubs, the success of our junior tour is a vital part of our section's operations!

PGA Financial Assistance Fund Scholarship Program

Graduating high school seniors and college students who are the children or grandchildren of PGA members are invited to apply online at the home page (before you log in) of PGALinks.com to be considered for financial support for college through the PGA Financial Assistance Fund Scholarship Program.

The scholarship program is an academic based scholarship program that takes into account the following depending on the class level of the student:

High School Graduating Senior

- High School Cumulative Grade Point Average must be at least 3.0 (60% of the scholarship weighting scale). This number is to be an unweighted GPA based on a 4.0 scale.
- ACT and/or SAT test scores (30% of the scholarship weighting scale)
- Extracurricular activities in high school such as sports, clubs, student government, community service, part time employment, etc. (10% of the scholarship weighting scale).

<u>Current College Student (has not reached their senior year in college)</u>

- College Cumulative Grade Point Average must be at least 3.0 (60% of the scholarship weighting scale)
- Most recently completed college semester or quarter GPA (30% of the scholarship weighting scale)
- Extracurricular activities in college such as sports, clubs, student government, community service, part time employment, etc. (10% of the scholarship weighting scale)

The amount and number of scholarships is determined by the availability of funds, and may vary from year to year based on these factors and IRS guidelines. Scholarships are awarded at the discretion of the PGA Scholarship Committee.

The application process will be live online between November 15, 2011 and March 15, 2012 of each year, and students are asked to wait until they are in possession of their most current grade report (first semester) or transcript before applying. The applicant must enter the students Social Security number and the PGA affiliated parent or grandparents PGA ID number to gain access to the application.

After submitting the online application, the applicant must send by March 15 to the below address a sealed official school grade transcript that shows their GPA information and ACT/SAT test scores (if a high school applicant) to:



Golf 2.0 & YOU

Whether it is a daily fee course or private club, the golf industry is acutely aware of the need to promote more rounds and revenue among existing players while reaching out to potential golfers.

Many cite PGA programs such as Play Golf America, PGA Free Lesson Month, Patriot Golf Day, PGA Free Fitting and Trade up Month and Get Golf Ready as examples of promotions they employ.

As Golf 2.0 rolls out, the PGA of America joins forces with industry stakeholders such as the USGA, PGA Tour, National Golf Course Owners Association as well as many of the country's largest multiple course operators in a strategy to:

- 1. Encourage more play among existing golfers
- 2. Reach out to those who have played in the past
- 3. Generate new players

Two of the immediate key Golf 2.0 action items that a proactive professional can implement:

- 1. Scheduling a business planning session with the board, owner or general manager, and golf course superintendent where a player development strategy is the major initiative for 2012
- 2. Promoting a facility-wide knowledge/awareness of player development emphasis, efforts and programs

As you develop plans for the new season, formalizing and reinforcing player development as a key or <u>the</u> key initiative for your facility for 2012 is essential. Accomplish this through a process complete with goals and objectives, action plans and measurable desired results will help validate its importance and promotes buy in.
