Golf 2.0 - Engaging Lapsed Women Golfers - Is Your Course Really "Women Friendly"?

My fellow PGA Employment Consultant Wayne Kauffman has a great article in the September issue of PGA Magazine titled "Make It a Family Affair". It is on page 142 and I recommend you read it! His article stresses how important it is to address all the various demographics of potential golfers.

A particularly interesting part of the article dealt with how few courses are truly "women friendly". He cites Suzy Whaley, a notable PGA Professional and currently District 1 Director, who commented on this topic at a Connecticut Section Meeting. Her statement was, "You all tell me how you have made your courses women friendly. Well, I have been to your places and not one of you are accommodating to women." She went on to say that any woman who showed up at their courses and tried to take up the game would go away totally frustrated.

You should look at your ladies' tees, you may be surprised that even at that length your course would be too long and frustrating for a mature woman trying to take up the game. That is why initiatives like TEE IT FORWARD and PGA Family Course should be regular, on-going programs that enable everyone taking up the game and even those who cannot hit it far enough to regularly enjoy playing! How does your course stack up?


